**Otsuka Pharmaceutical Factory obtains import drug license of Cefazolin Sodium for Injection/Sodium Chloride Injection in China**

Otsuka Pharmaceutical Factory, Inc. (OPF) obtained an import drug license for Cefazolin Sodium for Injection/Sodium Chloride Injection from the CFDA (China Food and Drug Administration) on July 26, 2017.

An antibiotic kit product, a first of its kind to be imported and distributed in China, will be exported by OPF from Japan while its subsidiary, Suzhou Otsuka Pharmaceutical Co., Ltd. will take charge of the marketing and sales management of the product. Local distributors will be appointed to import and distribute the product.

The product that has received approval in China was originally launched by OPF in 1996 as the first antibiotic kit product in Japan, and is currently sold in the market under the name of Cefazolin Sodium Injection 1g Bag Otsuka. The kit product involves one plastic bag separated by a seal and contains antibiotic in one chamber and diluent in the other. The product was developed for the purpose of easing the work load for users at medical institutions at the time of administration and dispensing, as well as for the prevention of bacterial and other contamination, and reduction of waste disposal

Shinichi Ogasawara, President and Representative Director of OPF commented, “Otsuka group started its business in China in the early 1980s with IV solutions. I am very pleased with the approval of importation and distribution of the kit product as it will furthermore contribute to the healthcare of China.”
